# ILLINOIS ASSOCIATION OF COUNTY VETERANS ASSISTANCE COMMISSIONS 

RESOLUTION 21-001<br>THE ASSOCIATIONS SUPPORT OF LEGISLATION

WHEREAS, the Illinois Association of County Veterans Assistance Commissions' members are tasked with providing for Veterans well-being and to enhance the quality of life of the Veterans and their families of the State of Illinois; and

WHEREAS, as part of providing that welfare, the Legislative Committee will monitor all legislation affecting Veterans and their families in Illinois whilst supporting the following proposed bills; and

WHEREAS, the Property Tax Code should be amended to include an exemption for a surviving spouse who is certified by the United States Department of Veterans Affairs as being a current recipient of Dependency and Indemnity Compensation; and

WHEREAS, Veterans preference requires the Department of Central Management Services to submit an annual report concerning certifications issued to veteran-owned small businesses and servicedisabled veteran-owned small businesses and requires the Department to conduct a minimum of 2 outreach events per year to ensure opportunities and certification requirements with the State; and

WHEREAS, a taxpayer who has been granted a homestead exemption for Veterans with disabilities need not reapply if he or she has been found by the Department of Veterans' Affairs to be permanently and totally disabled; and

WHEREAS, amends the Higher Education Student Assistance Act with regard to the Illinois Veteran grant program, provides that, beginning with the 2019-2020 academic year, a veteran may transfer his or her benefits to a qualified dependent if certain conditions are met; and

WHEREAS, provides that, if a veteran with a surviving spouse was in the process of review to receive the homestead exemption for veterans with disabilities, but the veteran died before the exemption was approved, then the application process shall continue and any subsequent approval granted to the veteran shall carry over to the spouse as long as the spouse meets the requirements; and

WHEREAS, department of Financial and Professional Regulation shall reduce all application fees and examination fees by $50 \%$ for Veterans; and

WHEREAS, provides that the Homestead Exemption for Veterans with disabilities carries over to the benefit of the Veteran's surviving spouse if the Veteran resided outside of the state but otherwise qualified for the exemption at the time of his or her death and the surviving spouse relocates to Illinois after the death of the Veteran; and

WHEREAS, the Department of State Police shall allow for a non-resident license application if the applicant is employed by the United States Military, permanently assigned in Illinois on Permanent Change of Station or Permanent Change of Assignment orders and who is not a resident of the State but maintains an address in the state; and

WHEREAS, for the 2019 taxable year and thereafter, the exemption for Veterans with disabilities carries over to the surviving spouse of a Veteran who did not obtain the exemption before death, but who would have qualified for the exemption in the current taxable year if he or she had survived; and

WHEREAS, creates the Veterans' Disability Compensation Task Force and provides specified objectives for the Task Force. Provides that the Task Force shall consist of 15 members appointed by the chairs of the Veterans Affairs Committees in the House of Representatives and the Senate. Provides that the members of the Task Force shall be members of different Illinois counties' Veterans Assistance Commissions, Veteran Service Officers, and members of Illinois state recognized Veterans Service Organizations; and

WHEREAS, anyone who purposely misrepresents an animal as a service animal commits a petty offense; and

WHEREAS, amend the School Code and allow a school board to establish a voluntary "Civic Engagement Day" in which a student in the 7th through 12th grade may request an excused absence of not more than one full school day per school year to participate in an organized civic engagement activity or event; and

WHEREAS, amend the State Employee Group Insurance Act of 1971, Counties Code, may not deny a claim from a medical facility operated by the Veterans Health Administration of the U.S. Department of Veterans Affairs on the basis that the medical facility is an out-of-network provider; and

WHEREAS, create the Veterans Bill of Rights Act and requires the Department of Veterans Affairs to make specified efforts to: (1) increase loans to small business concerns owned and controlled by Veterans or service-disabled Veterans; (2) increase Veterans access to health care coverage and services; (3) take specified steps toward preventing Veteran suicide; and (4) develop and implement a strategy to end veteran homelessness within 3 years; and

WHEREAS, create the Military Service Members Parking Space Act, that each State agency and constitutional office shall, at each location, designate at least one parking space on its property, as near to the front entrance as possible, for use by military service members only; and

WHEREAS, create an income tax credit for taxpayers who are caregivers of a Veteran with a disability that shall be in an amount equal to $5 \%$ of the costs incurred, not to exceed $\$ 1,000$; and

NOW, THEREFORE, BE IT RESOLVED that members of the Illinois Association of County Veterans Assistance Commissions call upon all to distribute this resolution to all lawmakers, local and state officials to support, endorse and pass all aforementioned legislation into law.

BE IT FURTHER RESOLVED, that The Illinois Association of County Veterans Assistance Commissions does hereby authorize the Legislative Committee and its Chairman to act on behalf of the Association in advocating for the legislation described heretofore.

Advised both VACWC and County have new reporting/accounting systems, reports not yet available; advised will send email with quarterly report numbers asap.

D. Project165 Report Valerie Tawrel

Tawrel advised currently 8 veterans, 2 community members currently housed in hotels; 3 females, 7 males; 9 have been housed including 4 families; member Janet Blue has been involved $w /$ assisting one of the females; Tawrel advised 3 most recent admissions had been sleeping in their car; VSO Solum advised eviction moratorium has not yet been lifted; Tawrel advised received 6 inquiries re: impending evictions; Horne inquired re: cold shelter assistance from cities/county, Tawrel advised Daybreak is providing 9p-8a emergency cold shelter; Tawrel advised congregate shelter thru CoC are ongoing conversations, advised limited space;
McNichol advised United Way of Will County Emergency Food and Shelter grant from FEMA is available; WCVAC applied for additional $\$ 60 \mathrm{k}$ reimbursement for noncongregate housing, put monies in separate line item to track, intent to use for SSVF eligible veterans for cap of 30 days; will then transfer to Project 165 if eligible; none of these expenditures involve regular housing budget; VAC is paying $\$ 2550$ per month per room; location is Quality Inn, 135 S. Larkin, Joliet IL

A. By-Law Discussion/Review: Atty. Lisa McGlasson

McGlasson advised results of By Laws -
Article II - changed to "promoting the welfare of honorably discharged members of the military and their families"; this change allows for greater freedom

Section 3 - removed the word "indigent"; this change allows greater freedom Section 5 - incorporate the Statute; allows any changes to be incorporated without making changes to the ByLaws
Article $V$ - membership
-language of the Statute is broader, allows for more freedom of inclusion;
McGlasson - 'other organizations' inclusion; any organization that comes forward will then be allowed a vote
Section 3-incorporated language from the Statute to further delineate, clarify and open membership to 'other' orgnizations
Section 5-clarify one vote per person/delegate; rewritten for clarity
Section 6-edited for clarity; requirement of "honorable discharged veteran" not supported by the Statute;

Horne advised original language chosen intentionally, suggests allow for exceptions;
McGlasson suggested change to "member in good standing of their organization" or similar language; Horne cautioned reefing too open, value of requiring organizations to prove their commitment;
McGlasson advised as it is currently written an organization of active-duty Guardsmen would be ineligible; advised Congressional/State charter/recognition is required, minimum of 15 members;

McGlasson suggested language, "approved by President/Board"
Section 7-removed 'require a vote to replace a delegate'; changed gender pronouns Article VII - Officers
Section 1-remove specific calendar dates from By Laws
Horne advised historically date was aligned with County budget
Section 6 - clarity re: fiscal year
-added "relationship to eligible veteran" to accommodate family members who do not have a DD214 of their own
Article VIII - Executive Board
Section I-clarified three (3) members
Section II - added - "The list of Executive Board..."; placed responsibility for maintaining list on Board
Section 11- trainings, Open Meeting Act, etc. required of completing, maintaining of Board members; Secy. will provide requirements, track completion
Section 12- requirement of Board members, Attorney General
Article IX-Standing Committees
Section 1- added "members"
Section 2-"All committees, including ad hoc committees, shall include a VAC staff member to provide administrative support and ensure statutory compliance of the committee"; to address potential financial, record keeping requirements, etc.
Article X-
Section 1 -adjust language re: "honorably discharged veteran" requirement for appeals; statutory requirement will be checked
Section 3 - adjust language re: campaign/conflict membership
