### C. Project 150

- a) <u>NEW</u> ESG-CV Funding from County (Emergency Shelter)
  - 1. Entry into program will be following guidelines of new HUD/VASH
  - 2. Discussion:

VAC Staff Tawrel stated normal emergency shelters are full and still operating under lower capacity than pre-COVID19. There is no emergency shelter option for single women. When eviction moratorium is up, those evicted, OR lease not extended will have nowhere to go.

Will County lacks affordable or sustainable units.

Member Blue: Why is housing not being built with funding available. Monee has property they are looking to develop. Guest Garland Mays: Reviewed that building a multi-family complex is not the same as building a home. COVID-19, though not an excuse, did cause a supply shortage and then a cost increase. Furthermore, building a multi-family unit requires development developers and possibly a needs and infrastructure study to be completed. All take time.

Superintendent McNichol echoed what Mr. Mays said. President Picciolo: There are more homeless on the streets right now, and he knows there will be more. Communities need to find a solution. Eviction Moratorium deadline will cause an influx of homeless, and there is no plan in place right now. That is why VAC ESG funding was needed. VAC has a plan.


- A. VAC intro: Garland Mays, Community Coordinator, Will County Executive
  - a) Mr. Mays thanked VAC Board for in-depth discussion on needs in the community. The County Executive Office is working on strategic plans to meet the needs.
  - b) Mr. Mays discussed lack of public transportation in Will CO.
    County Exec. Team is currently working on revitalizing that program. A press release will be soon.
  - c) Mr. Mays is very aware of housing shortage. He also sits on Housing Authority of Joliet Commission. At HAJ last application process, there were 42 units available; HAJ received over 600 applications.
