1. Appoint Judge Advocate

Williams requested prior to vote for Lisa McGlasson to introduce herself, her qualifications

- -McGlasson advised she has submitted a letter of introduction to the board, reiterated her qualifications
 - -Horne asked ASA Wise if this action is allowable in By-Laws
- -Williams asked ASA Wise if there is any thing in the By-Laws that prevents naming a Judge-Advocate; ASA Wise stated no.

Koch asked if Judge Advocate votes, per ASA Wise, no, no voting rights, not a member of the Executive Board

2. Review IGA Progress

McNichol advised she, ASA Wise, Jack Picciolo, Wayne Horne, Co. Exec ASA Mary Mahoney and Jen Solum met, went line by line thru the IGA;

- -Koch asked if the County will sign it first
- -Wise stated this board does not generally like to sign agreements until they are signed, can be officially voted on at next meeting
- -Koch asked if the VACWC will be able to amend it at the next meeting prior to voting/agreeing/declining;
- -Wise advised it will not yet be signed by County, can be edited until VACWC and County signs -McNichol advised what is in "bold", section 2A (referencing the MVAA) that have been changed.
- -McGlasson clarified there are some sections still pending due to changes in the MVAA, still in the legislature
- -McNichol advised this IGA gives VACWC accessibility to county resources, VACWC employees are still VACWC employees, impetus behind this IGA is for the county board to better understand what the VACWC does, not to give county board control or oversight of the VACWC; also, IGA expires at the end of each County Executive's term;
- -Koch advised to note it is likely once approved, it will remain substantially the same term to term

- -Blue asked if Judge Adv. will look it over in her new official capacity
 - -McGlasson agreed to assignment
 - a. MVAA amendments; McNichol states was set for hearing, no news as of today.

3. Staff update

McNichol advised Admin. Asst. has been hired, interviewed by Williams, McGlasson

- -McNichol advised first priority will be handling D365, second priority for new Admin Board Meetings
- -Third is records disposal
- -Fourth is Financial Assistance, she will be "step 3": Asst. Superintendent process; Superintendent Approves; Exec. Assit Enters into D365; Superintendent Approves.
- -Fifth Exec Asst. will pull reports on staff from Vetra
- -Horned asked about her veteran status
- -Williams/McGlasson advised she is the spouse of a veteran, lived on active duty base

McNichol stated second staff update is her resignation, requested Secretary Williams read her resignation into the record (attached below)
