VI. SUPERINTENDENT REPORT

- A. Award Log
 - a. The numbers are through August 30 with the total awards for the year vs 2023 as a comparison.
 - b. Increase from 1047 to 1230 with awards
 - c. Total amount from Jan 1- August 30 for retroactive amounts is \$7,201,246.08.
 - d. New veterans added 185 from the last meeting.
 - e. December 1-August 30th 2024: Office visits were up 609, emails 802, calls 1292
 - f. The numbers will look different meeting since the report form will be different due to a new system but will work on showing a comparison.
- B. Financial Assistance
 - a. Uptick in a number of veterans served
 - b. To date there was 26 veterans helped for gas, 29 veterans for electric bills, 11 water and sewer
 - c. Rent and land building helped 47 veterans
 - d. FYI: 2025 re writing the financial assistance to do a procedure to help get the benefits up with the qualifications down.
- C. Veteran Problem-Solving Court
 - a. 156 veterans were helped this month.
 - b. Outreach with 15 veterans in the last 6 months
 - c. Helping the veterans get back to where they were picked up from
 - d. Assistance and guidance is provided to help with substance abuse or mental health issues to help get the veteran back on track.

- D. Mental Health Coordinator
 - a. March of 2024 the program was introduced to other groups in the area. 18 organizations were reached out to for letting them know what is being offered.
 - b. Veteran did not want to go back to the VA so has been coming to the VAC for help
 - c. Certified grant writer
 - d. Access to veterans who are in jail or prison to help see what benefits their family would be available for.
 - e. Search for funding to help grow the program as well as other opportunities we could help the veterans.

VII. UNFINISHED BUSINESS

- A. 1300 Copperfield Building Update
 - a. JBT and Mike Mahoney attended to provide the update for the Copperfield building.
 - b. JBT: The building was purchased prior to JBT taking office. Intent is to put the VAC as well as other county offices there.
 - c. The intent was never to not put the VAC offices there.
 - d. The county board went back and forth to keep it or sell it but was determined to keep the building. The county board decided to get rid of the building and then a couple months later they decided to keep the building.
 - e. They are committed to holding on to the building.
 - f. 4 story former medical office building bought in 2021. The building was built in 2003. 7200 total square feet. The intent is not for the VAC to take the entire building. They will take the 1st floor which use to be the cardiac floor. Includes a track and bathrooms with showers. A place for veterans to work out and hang out.
 - g. 4th floor possibly transitional housing for veterans. Right now is step 1 to retrofit the basement and the first floor for the VAC.
 - h. 4 million available for the roof and critical systems in the building. Hoping to complete some of it by the summer of 2025.
 - i. Good location with the medical center and the housing right there.
 - j. Looking at other Nonprofits to possibly come in to serve as a one stop shop.
 - k. Hired a firm to take a look at it to do a format with where we could have some offices.
 - I. We are hoping to see movement this year with the roof.
 - m. The primary goal is to keep the building veteran focus first.
 - n. As representatives of the county we looked at the transitional housing as well as Nonprofits like K9 for vets. Want to make sure the conversation continues.
 - o. Coming down for funding to help with the bigger picture.
 - p. Looking for federal grants to help get at the bigger picture.
 - q. First priority is to get the VAC over there.
 - r. There are a lot of pipes that will need to be rearranged and taken out which was seen on the tour.
 - s. Looking at the IDVA, VA and Crisis center to try and bring on board once the VAC gets in there. This would allow to have more veteran services in one spot.
 - t. Multiple people and groups pushing for this. The money is ready to start the needed construction.
