It is with great pleasure to present you with the annual report of the Veterans Assistance Commission of Will County, Illinois, pursuant to Chapter 330, Part 45, Section 8 of the Illinois Compiled Statutes.

With 26,162 veterans, Will County has the third highest veteran population in Illinois. The Veterans Assistance Commission of Will County (VACWC) has the privilege of providing services in the following categories:

- Veteran Advocacy
- Veteran Financial Assistance .
- Veteran Benefits and Compensation Assistance

In 2024, the VACWC assisted 3,857 veterans, their dependents, and their survivors to obtain the benefits they earned from the United States Department of Veterans Affairs (VA). This resulted in \$10,809,228.23 in new benefits returned to the veterans and the community. The VACWC is proud to be the only Veterans Assistance Commission in Illinois to work alongside the Illinois Department of Veterans Affairs (IDVA). This collaboration benefits Will County veterans by having an IDVA service officer within the VACWC office to provide benefits and information on the state level.

The VACWC continues to be the foremost veteran advocacy agency in Illinois. Our cooperative relationships with local service agencies, and our collaboration with the VA, gives us the opportunity to assist Will County veterans, their dependents, and their survivors with their individual needs and unique challenges that are specific to this population.



### **FINANCIAL ASSISTANCE** SERVICES

Veteran Financial Assistance is available to Will County Veterans, their dependents, and surviving spouses that meet the eligibility criteria. The financial assistance is allotted directly to the vendors for rent/mortgage, utilities, and personal needs. The VACWC requires each participant to adhere to the VACWC financial assistance policies to maintain eligibility to receive benefits.

Every veteran, family member, or surviving spouse, if needed, may utilize the food pantry in the office. Hygiene items and food are donated throughout the year from various local partners and residents.

This year, the VACWC provided \$27,370.62 in financial assistance, representing \$22,258.31 in rental and mortgage assistance and \$5,112.62 in utility assistance for indigent Veterans and their families.

In 2020, an update to the VACWC financial assistance policy limited eligibility resulting in a significant decrease in benefit disbursement. Several factors have caused an increase in the need for financial assistance: inflation, lack of housing inventory, loss of employment, and veterans on a fixed income. In 2025, the VACWC will update the financial assistance policy to make benefits more accessible to veterans in need.

### WILL COUNTY DEMOGRAPHICS

### WILL COUNTY HAS 26,162 VETERANS

#### 24,053 Male Veterans 2,475 Female Veterans

The male population is expected to decrease by an average of 1.5% and the female population is expected to increase by 3.2% each year over the next 5 years.

Over the past 5 years, the unemployment rate for veterans has been significantly lower than nonveterans. However, in more recent time, the unemployment rate between both categories has become nearly equal. The rise of veteran unemployment is concerning. The VACWC does attempt to combat this statistic by referring our clients to Department of Veterans Affairs Vocational Rehabilitation Programs, Will County Workforce Solutions and other local job fairs.

Additionally, the median income for veterans is statically higher than non-veterans. Please note, that the median income does not include awards from the VA. Awards from the VA is not considered income. Will County Veteran Poulation by Gender





Veteran Disability Ratings







#### Figure (d) represents the percentages at which Will County veterans receive service connected disability. Service connected disability benefits are tax-fee monthly payments to veterans who were injured or disabled as a direct result of their military service.

The amount of compensation a veteran receives is determined by their disability rating. Our goal is for each veteran to receive the proper compensation based off their overall physical evaluations.

Will County is also home to Active Duty, National Guard and Reserve service members. Figure (e) represents the total number of service members in each category. The VACWC actively provides outreach to these specific individuals to provide education and awareness for when they are ready to pursue benefits.

Figure (f) represents Will County veterans by age group. There are 5,112 veterans between the ages of 17-44; 8,119 veterans between the ages of 45-64; 10,760 veterans between the ages of 64-85; and 2,534 veterans over the age of 85.

### **HELPING THOSE** IN NEED

#### **VETERAN RECOVERY MEETINGS**

Joseph Martin is an Army Veteran who joined our team in 2021 as the Veteran Peer Support Specialist. The COVID-19 crisis highlighted the need in the community for support with mental health and addiction recovery. Joe runs a weekly "Time for a Change" Veteran Outreach Peer Support Recovery Group with an average of 5-7 veterans in attendance. In October 2023, Joe earned an additional certification, Peer Support Specialist.

#### **VACWC FOOD PANTRY**

The Will County VAC operates a dedicated food pantry to support veterans and their families in times of need. Recognizing the sacrifices made by those who have served, the pantry provides essential groceries, fresh produce, and non-perishable items to ensure no veteran or their family goes hungry. With a focus on dignity and respect, the food pantry creates a welcoming environment where veterans can access the support they deserve.

We are one of the only organizations in the area that offers fresh meat and eggs! More importantly, we keep an ongoing list of families that need additional items during the holidays. This year we had an abundance of turkey and ham dinners with sides provided by Mike Meyers of the Lockport American Legion Post 18.

This vital resource is sustained through the generosity of the community, local partnerships, and volunteers committed to making a difference. Whether it's helping a veteran through a difficult month or providing consistent support to families, the Will County VAC food pantry stands as a beacon of care and compassion. Veterans in need are encouraged to visit the pantry and experience firsthand the gratitude and support of the community they've served.

#### **HOMELESS VETERANS PROGRAM**

THE PRIMARY OBJECTIVE of our homeless prevention program is to house veterans and ensure they are on a path towards stable and supportive permanent housing. Joe is also the coordinator and first point of contact for veterans and their families who are facing homelessness. Joe plays a vital role in connecting the veterans with VA resources to assist in transitioning into permanent housing.

Every Wednesday afternoon at the VACWC, in collaboration with Hines VA, Volunteers of America, Midwest Shelter for Homeless Veterans, and other partnering agencies, walk-in appointments are available for veterans and their families to meet with a housing coordinator. On average, the team meets with 4 new veterans and their families who are "literally homeless" per week. During this appointment, eligible veterans are enrolled in VA healthcare, evaluated for the HUD VASH program and/or rapid rehousing, and for drug/alcohol treatment if needed. If needed, the team will coordinate inpatient treatment through Hines VAMC, or services through Stepping Stones Treatment Center.

In addition, if needed, admission to Daybreak or Morning Star Mission shelters is arranged. During this process they are also screened for eligibility for financial assistance, as well as VA compensation claims. In 2024, 192 veterans and their family members were assisted through this program.

#### **VETERANS TREATMENT COURT**

Joe is the liaison for the VACWC with the Will County Veterans Treatment Court. The mission of the Veterans and Service members Court is to provide qualifying individuals mental health, mental disorder and/or substance abuse treatment through judicial intervention utilizing a collaborative, non-adversarial approach to promote public safety. As a Peer Support Recovery Specialist, Joe has an integral role in supporting the veteran to ensure their success. Joe collaborates and meets weekly with the program Psychologist, Probation Officer, and Social Workers to make sure the veteran is on the path to success.

### **VETERAN** SERVICE OFFICERS

#### NACVSO ACCREDITATION

In May of 2024, WCVAC VSOs attended the 2024 NACVSO Conference in Denver, Colorado. VSOs are required by the VA Office of General Counsel to maintain accreditation in order to be a veteran advocate.

The VACWC is a proud member of IACVAC. This organization consists of Veteran Service Officers throughout the State of Illinois. Their mission is to foster and perpetuate VAC's in all counties where viable commissions do not exist and provide The purpose of NACVSO is to train & educate VSOs and information and training as necessary. #### **ILLINOIS ASSOCIATION OF COUNTY VETERANS ASSISTANCE COMMISSIONS**

### **VA BENEFITS ASSISTANCE**

Advocating on behalf of Veterans involves assisting with the filing of claims for compensation, pension, education, and healthcare to local, state, and federal agencies including the Department of Veterans Affairs (VA). The Veteran Service Officers (VSO) at the VACWC are accredited through the National Association of County Veteran Service Officers, and cross-accredited with the VFW, DAV, and American Legion.

The number of veterans served by the VACWC in 2024 was higher than the preceding years, to include 1375 first time veterans to our office. The total annual award amount reflects the increase of benefits. This increase was a result of the expansion of VA benefits and programs, return to our pre-pandemic outreach initiatives, addition of 4 new VSOs, and the hard work and dedication of the VACWC team and the Commission.



## **ANNUAL AWARDS REPORT:** FY2024

Our annual award log report is a representation of the monetary benefits awarded to our clients. It is a combination of VA Benefits and WCVAC Financial Assistance.

Because we updated our system for tracking Veteran benefits, the numbers that are represented on the right are for FY 2023 and FY 2024.

This is snapshot of our progression as of December 2024. We are pleased to have grown 119% since last year. Our services delivered 28.10 million dollars since 12/30/22, of which 10.8 million is from 2024, into the households of veterans and their families. Of that, 5.92 millions dollars includes the one-time retroactive payments into the pockets of veterans and their families.

#### Why the increase?

The VACWC underwent staffing changes in 2022, hired two additional VSO's in 2023, and one VSO in 2024. In a short time they were trained, accredited, and able to process claims and benefits.

On average, we are seeing 60 appointments per week, and the majority are first time claimants. The increase in new veterans is a result of our increase in outreach efforts in our community.

We have also seen an increase in claims for service connected disability since the PACT ACT of 2022. This legislation approved new presumptive conditions for the exposure to toxic environments and occupational hazards.

In addition to the claims filed with the VA, the VACWC also submitted 209 applications for VA Health Care benefits. This resulted in over 200 veterans receiving access to VA health care in our community.

### **ADVOCACY** REPORTS

#### TOTAL COMMUNICATION

Customer service is a top priority at the VACWC. On average, the service officers have 4 in-person appointments per day. Each appointment lasts for 1.5 hours to ensure quality control and assurance for each claim.

#### **OFFICE VISITS**

Figure (b) indicates the total amount of office visits, per month, for the fiscal years of 2023 and 2024. Data was not available for Sep-Nov 2023 due to a software upgrade. The data set concludes that we have nearly doubled in client visits. This notable factor is important because it translates to the 119% increase in total benefits awarded.

We attribute the increase to all the outreach events we attend, first time claimants, and *your* word of mouth for referrals. We encourage every veteran to explore the VA benefits that they may be eligible for. Our VSO's have personal one-on-one meetings with each veteran or family member to expertly research their military records and complete all necessary claim documentation.






### **NEW BENEFITS RECEIVED**

In 2024, the total amount of benefits awarded since 12/30/2022 was \$28,108,668.35. Total amount of NEW benefits paid by the VA for 2024 is \$10,809,228.23.

New benefits are broken down into three categories which include Retro payments, Increases in Monthly Benefits, and First Time Claimants.

The total impact does not include preexisting revolving payments, medical benefits, and VACWC financial assistance.

These payments are updated monthly by each VSO to ensure maximum accuracy for each veteran they assist.

#### **CLAIM SUBMISSIONS & SUPPORTING DOCUMENTS**

Figure (d) represents the total number of claims submitted by type. There was a total of 2,185 claim submissions this year. This figure does not represent the amount of supporting documents.

The VA claims process requires a high level of knowledge and research. The average VA claim takes 159.6 days. Each VSO is held accountable to track every claim they submit until it is adjudicated. Therefore, VSO's are constantly updating veteran profiles with new and relevant information to make for a successful claims process.



### **VETFEST** 2024

The VACWC and the Joliet Battle Buddy Program came together to hosted the 2nd annual VetFest, an event filled with community spirit and a shared dedication to supporting our local veterans and their families.

Attendees enjoyed browsing booths from local vendors that included representatives from the Department of Veterans Affairs, Will County Treasurer, Will County Auditor, Will County EMA, Will County Recorder of Deeds, Will County Sheriff's Auxiliary, local veteran organizations, and multiple police and fire departments from within Will County. All vendors offered information and assistance that is beneficial to veterans and their families, and also some fun giveaways.

Although it was a wet and rainy day, our event featured an impressive car show, showcasing vehicles that brought car enthusiasts from all around. Everyone had the opportunity to enter exciting raffles while enjoying delicious smoked barbecue.

Despite the weather, we had a great turn out and the rain further embraced the military spirits. "If it aint rainin', we aint trainin'!!" said Assistant Superintendent Erik Papineau.

The heart of VetFest was its mission: support those dedicated to veteran suicide prevention. Every dollar raised during the event was donated to AllenForce, a nonprofit organization dedicated to empowering veterans through health, wellness, and community reintegration programs.

### **NEW BUILDING COMING SOON!**

Excitement is building in the Will County veteran community as the VACWC prepares to move into its new facility at 1300 Copperfield Avenue, Joliet, Illinois. Located conveniently next door to the Joliet VA Clinic, the state-ofthe-art building will allow the VACWC to expand its services and create a comprehensive one-stop shop for veterans.

The move to the new location marks a major milestone for the VACWC, which has long served as a vital resource for local veterans. By expanding its services and consolidating resources into one centralized hub, the VACWC aims to better serve the needs of Will County's growing veteran population.

"This move represents a tremendous opportunity to provide more streamlined and effective assistance to the men and women who served our country," said Erik Papineau, Assistant Superintendent. "Being right next door to the VA Clinic means veterans will have greater access to healthcare and support services all in one location."

The new facility will feature enhanced space for benefits counseling, employment assistance, housing support, mental health resources, and a functional fitness gym! Additionally, the VACWC plans to partner with local organizations to offer expanded programs for education, financial literacy, and peer support.

For many veterans, the proximity to the Joliet VA Clinic is a game-changer. The ability to access medical care and VACWC services within walking distance provides added convenience, particularly for those facing mobility or transportation challenges.

Local leaders and veterans' advocates have praised the move, citing its potential to improve outcomes for veterans and their families. ### MENTAL HEALTH SERVICES

Samantha Lucko, LCPC, is the dedicated Mental Health Coordinator at the VACWC. She is expanding the organization's outreach on critical mental health programs aimed at combating veteran suicide. With a renewed focus on prevention and support, Sam's initiatives are strengthening resources available to veterans while breaking down barriers to mental health care.

Under Sam's leadership, the VACWC has implemented new strategies to engage veterans, including community workshops, peer-support programs, and improved collaboration with local mental health providers. By focusin on education and intervention, the VACWC aims to identify those at risk while creating an open dialogue about mental health challenges.

### **ADDITIONAL** SERVICES

#### **VACWC TRANSPORTATION PROGRAM**

The VACWC has a transportation program that provides rides to veterans for medical appointments at VA facilities or private medical centers. The VACWC has 2 vans, of which 1 is wheelchair accessible. The wheelchair accessible minivan gives us the opportunity to provide transportation for veterans with mobility issues. In 2024, the VACWC provided veterans more than 295 round trip rides to medical appointments at VA facilities or private medical centers.

We also use these vans to pick-up and drop-off food deliveries and for of our Helping Those in Need program. Donations come from all around. We accept our donations from local businesses such as Costco, charitable distribution centers such as Share Fest Will County, and of course all of the veteran service posts in our surrounding area. We express our gratitude to this strong community for all of the endless support and combating veteran hunger.

### PARTNERING AGENCIES

The VACWC is fortunate to partner with Farm2Veteran. Farm2Veteran is home to a variety of livestock, a greenhouse and a garden that produces quality food for veterans in need. Through farm-fresh food, Farm2Veteran strives to play a pivotal role in the lives of veterans by supporting their nutritional needs. Farm2Veteran donated to the WCVAC two freezers and a refrigerator so we can have fresh meat and eggs available to our veterans in need. Farm2Veteran keeps the freezers and refrigerator full!

Northern Illinois Food Bank and Share Fest are two local organizations that we utilize to keep our food donation pantry full.

We have also established regular working relationships with different departments at our local VA medical centers. This allows us quick and easy access to additional VA benefits such as Vocational Rehabilitation and HUD VASH which is a collaborative program between the US Department of Housing and Department of Veteran Affairs. This program offers supportive services to homeless veterans and their families.

The Joliet Police Department created their "Battle Buddy" program for veterans and active members of the military in the City of Joliet. The program has a select group of police officers who have served in various branches of the military. The Joliet police will specifically dispatch a Battle Buddy Police Officers to calls for despondent and/or suicidal veterans. Each volunteer member has taken critical incident and crisis intervention training.

The VACWC also hosts the Orland Park Vet Center (OPVC) in our office Monday – Thursday. OPVC provides veterans with combat and/or MST counseling, referrals, and community engagement. OPVC services are available at no cost, regardless of discharge character, and without the need to enroll in VA Healthcare, or be in receipt of a service-connected disability.

Another great organization is Operation Team Rubicon. This is a veteran-led humanitarian organization that delivers impactful disaster relief and aid nationwide. The VACWC has teamed up with Operation Team Rubicon multiple times to assist veterans in need. This is the go to organization if veteran families are in need of true man or woman power.
